#### **Job Summary**

 This role is a new position for a suitably qualified person to assist in achieving continued improvement in Health and Safety performance and service delivery.

 To undertake a range of duties commensurate with your experience and competence, including conducting periodic audits and inspections of Academies Trust wide and assisting in conducting accident or incident investigations in the workplace.

### **Main Duties and Responsibilities**

- To carry out workplace audits and inspections to identify and recognise good practice or any shortfall in health and safety standards or safe working practices.
- To report findings to Managers with prioritised recommendations for remedial actions.
- To provide advice and support to managers in responding to accident and incident investigations and RIDDOR reportable, or other loss events.
- To provide an advisory service embracing all areas of health and safety risk management, including policy development, risk assessment methodology, workplace inspection and audits, investigating, recording and reporting of accidents, dangerous occurrences or near-misses.
- To maintain competence in a rapidly changing legislative environment by continuous professional development.
- To provide termly H&S reports to senior leaders.
- Assist in the training and development of staff and to undertake personal professional training as may be deemed necessary to meet the duties and responsibilities of the post.
- To undertake any such other duties and responsibilities commensurate with the grading and nature of the post.
- The postholder will be required to have a flexible approach to work in responding to the needs of the Service.
- To review fire risk assessments across the Trust and provide guidance to staff.
